Anaheim Public Utilities provides financial incentives for new construction and rehabilitation of multi-family dwellings in order to promote sustainability, decrease tenant utility costs, and lower Greenhouse Gas (GHG) emissions.

*Affordable Housing criteria is defined either by the State or Federal funding source each year, with established annual income guidelines. All Affordable housing units shall be designated for each project and shall be based on the following criteria:

1. A project maybe designated as 100% Affordable w/Tenant incomes at or below 30%, 50% or 80% of the Orange County median - adjusted annually by Housing and Urban Development (HUD)
2. Mixed Income properties are only eligible for incentives for those units that are specified as Affordable

**Incentives shall not exceed purchase price; program is subject to available funding
