- Carnivals, Fairs, and Outdoor Assemblies-\$55.00. *(If submitted less than 10 business days prior to event, the application fees are doubled.)* Inspection Required.
- Pumpkin Patch Lots-\$55.00. Inspection fees will be invoiced after the event. *(If submitted less than 10 business days prior to event the application fees are doubled.)* Inspection Required.
- Christmas Tree Lots-\$55.00. Inspection fees will be invoiced after the event. *(If submitted less than 10 business days prior to event, the application fees are doubled.)* Inspection Required.
- Private Fire Hydrant Use-\$55.00.
- Haunted House-\$55.00. Inspection fees will be invoiced after the event. *(If submitted less than 10 business days prior to event, the application fees are doubled.)* Inspection Required.
- Recreational Fire in the Very High Fire Hazard Severity Zone-\$55.00. (As defined in Chapter 105.6.50 of the California Fire Code, as amended by the City of Anaheim.
- Liquid or Gas-Fueled Vehicles or Equipment-\$55.00. *(If submitted less than 10 business days prior to event, the application fees are doubled.)* Inspection Required. Not applicable to vehicles displayed as a part of permitted Trade Shows.
- Special Operational Permit, Other-\$55.00. *(If submitted less than 10 business days prior to event, the application fees are doubled.)* Inspection Required. Describe the Activity:

- Live Audiences in a Production Studio/Sound Stage-\$55.00. Inspection Required.
- Temporary Membrane Structures, Tents and Canopies-\$110.00. Inspection Required. NOTE: Applications for Tents and canopies that are submitted more than 10 business days prior to the event start date will be given a 50% reduction on their application fee.
- Model Rockets regulated by Title 19-No Fee Required.
- Open Burning-\$55.00. Fire > 3 ft. in diameter or > 2 ft. in height. *(If submitted less than 10 business days prior to event, the application fees are doubled.)* Inspection Required.
