

LETTER OF UNDERSTANDING
SERVICE EMPLOYEES' INTERNATIONAL UNION, LOCAL 1877
and the
CITY OF ANAHEIM

The Service Employees' International Union, Local 1877, (SEIU) and the City of Anaheim (ANAHEIM) have met and conferred in good faith and reached an understanding regarding employee wages and other terms and conditions of employment. The PARTIES have reached an understanding to amend the Memorandum of Understanding between the PARTIES in effect October 3, 2003 through October 4, 2007 as follows:

1. SEIU and ANAHEIM agree that Appendix "A" Wages will be modified to reflect a 4% base wage increase to be effective October 5, 2007:

2. SEIU and ANAHEIM agree to amend Article 20 - DURATION as follows:

17.1 *The terms of this Memorandum are to remain in full force and effect until the ~~4th day of October 2007~~ 8th day of January, 2009, except that either ANAHEIM or the UNION shall have the right during the sixty (60) days preceding to ~~October 4, 2007~~ January 8, 2009, to give written notice to the other of its desire to meet and confer with respect to the terms and conditions of this Memorandum. If new terms and conditions cannot be agreed upon by ~~October 4, 2007~~ January 8, 2009, this Memorandum shall*

become null and void. Upon adoption of a Resolution approving this Memorandum and the terms hereof by the City Council of the City of Anaheim, this Memorandum shall be in full force and effect.


