ACTION TAKEN

1. **CALL TO ORDER:** The Youth Commission meeting was called to order at 4:06 p.m. by Brian Chwan.

APPROVAL OF MINUTES: Brian Chwan presented the June 9, 2021 minutes to the Youth Commissioners for changes and/or corrections. Commissioner Rice made a motion to approve the June 9, 2021 meeting minutes, seconded by Commissioner Rodriguez; motion was approved with eight votes in favor. Brian Chwan accepted the minutes.

6. **NEW BUSINESS:**

- c) **Social Media – Brian Chwan, Community Services:** Brian Chwan asked the Commissioners for any ideas regarding Social media. The goal is to find and create procedures to post on behalf of the Youth Commission.
- d) **Anaheim Youth Commission Mission Statement – Brian Chwan:** Brian Chwan would like to have the Youth Commission create a mission statement. A motion was made by Commissioner Rodriguez to create a subcommittee to work on the development of the mission statement for the Youth Commission, second by Commissioner Zewdu; motion was approved with eight votes in favor.
