Re: Freedom of Information Act ("FOIA") and California Public Records Act Request

Dear Custodian of Records:

Under the Freedom of Information Act, 5 U.S.C. section 552, and the California Public Records Act section 3250, et seq., I am requesting an opportunity to inspect and/or obtain copies of public records regarding the extent of contamination at, or emanating from, the sites listed at the bottom. I am likewise requesting the administrative record log so that we may determine what documents you have available and what we may need. I am requesting all records including but not limited to, all records regarding past/present/future remediation, past/present/future cleanup, past/present/future property damage, any Feasibility Study, any Remedial Action Study, etc. Furthermore, while I am specifically identifying these sites as the possible location of the initial contamination, I am requesting all records regarding any/all locations that have been affected by pollution emanating from these sites, including but not limited to contamination of aquifers.

If there are any fees for searching or copying these records, please inform me of the cost. However, I would also like to request a waiver of all fees, because the disclosure of the requested information is in the public interest and will contribute significantly to the public's understanding of the extent of contamination, and the extent of remediation that has occurred and is still required.

This information is not being sought for commercial purposes. The California Public Records Act requires a response within ten (10) business days. If access to the records I am requesting will take longer, please contact me within the ten (10) days with information regarding when I may expect copies or the ability to inspect the requested records.

If you deny any or all of this request, please cite each specific exemption that justifies your refusal to release the requested information, and notify me of the appeal procedures available to me under the law.


