STEP 3: **WAIT** to receive an invoice for responsive records. The City shall determine within 10-days from receipt of a public records request, whether the request, in whole or in part, seeks copies of discloseable public records in possession of the City [GC 6253(c)]. Please note that if you are requesting the opportunity to inspect records, you will be requested to make an appointment to return at a later date/time to view the documents.

Charges for the direct cost of duplication will apply. **Documents will not be copied until payment has been received.** If payment is not received within 10 days after invoice is sent, you may be required to submit a new request. Please see backside for additional information.

Under the California Public Records Act and the new law that went into effect Jan. 1, 2019 under SB 1241, I would like to review all materials related to the Aug. 3, 2018 encounter at Maxwell Park between Voice of OC reporter Spencer Custodio and Anaheim police Sgt. Michael R. Lozeau.

The information I want to review includes all material, written, audio, video and in any other form, that Lozeau provided the department and any of its employees, including Public Information Officer Daren Wyatt, about his encounter and related events. I also want to review all material of any type that others in the department, including Wyatt, created about the encounter or what they were told or thought about the encounter.

*For example, Wyatt told Voice of OC that Lozeau said Custodio didn't immediately identify himself, which is untrue and put the encounter within the scope of SB1241, which covers incidents in which an officer lies.
