- Business is authorized to serve alcohol in the proposed outdoor dining area in accordance with the California State Alcohol Beverage Control (ABC) Department and a copy of the "ABC COVID-19 Temporary Catering Authorization" has been provided with this permit request or will be provided to the City Planning Department prior to establishing the proposed outdoor activity;
- Business operations will not obstruct any Americans with Disabilities Act (ADA) required paths of travel, including internal walkways/sidewalks, ADA parking stalls;
- Business operations proposed under this permit request will be conducted outside of the public right of way and will not to obstruct the line of sight of any pedestrian, bicycle or vehicle entering or exiting a property and shall be established in a manner that maintains safe pedestrian and vehicular movement which may include the placement of physical barriers or separations to protect customers from vehicle traffic;
- Business will obtain separate permits for any temporary tents/canopies from the Fire Department and/or for any electrical or construction work, including the installation of generators from the Building Division;
- Business has obtained authorization from the property owner/property management company;
- Business operator will make every effort possible to not cause a noise disturbance to surrounding properties or businesses and operating hours of outdoor dining area will not exceed the hours of indoor dining;
- Should any outdoor activity area cause a disruption to the safe operations of the property or result in complaints from adjacent land uses, I acknowledge that the City reserves the right to request modification to the approved outdoor dining configuration and/or to enforce the standards for "Special Event - Outdoor Activity" contained in Section 18.38.240.010 and "Outdoor Seating" and "Outdoor Dining" contained in Section 18.38.220, of the Anaheim Municipal Code.

Site Plan and Security Plan Submittal Requirements

In addition to the Application, applicant must submit the following:

1. SITE PLAN (Attach separately)

- Lot dimensions including property lines and label the names of the adjacent street
- Identify vehicle drive aisles, pedestrian paths, parking lot striping, and location of handicap parking stalls
- Identify all existing building(s) or other large structures on the property
- Label each unit/suite and building located on the property
- Identify and provide dimensions of the proposed outdoor area(s):
 - Label the **"Alcohol Consumption Area"** - the area where alcohol consumption will take place
 - Identify the number of parking spaces that will be used for outdoor area
- Identify the location of any perimeter fence, gate, and/or barriers (include the height) that will be installed/used to secure the alcohol consumption area
- Identify any proposed lighting or ancillary equipment or structures
