



## Anaheim Community and Economic Recovery Plan

- **What:** \$72.2 million in City Council-directed funding for seniors, families, workers, renters and businesses
- **When:** initially approved as \$15 million in aid by the City Council on March 26, 2020 and expanded from there with added programs and funding
- **How:** city funding, state and federal COVID-19 aid and existing grants
- **Community relief:** \$59.9 million
  - **\$20 million:** homeless programs
  - **\$30 million:** rental assistance
  - **\$3 million:** nonprofits
  - **\$3 million:** utility bill help
  - **\$1.7 million:** housing resources
  - **\$1.2 million:** help for workers
  - **\$1 million:** face coverings, testing, other needs
- **Business assistance:** \$12.3 million
  - **\$6.5 million:** booking conventions, attracting visitors
  - **\$4.8 million:** small business grants
  - **\$1 million:** shop, dine local marketing, restaurant relief grants
- **Funding:** federal Coronavirus Aid, Relief, and Economic Security Act, American Rescue Plan, California COVID-19 relief funds and local dollars



## Emergency Rental Assistance Program

- **What:** \$30 million program for tenants and landlords struggling amid the coronavirus crisis with back rent deferred under Anaheim's eviction moratorium, or state and federal eviction protections
- **Approved:** May 5, 2020
- **Funding:** federal Coronavirus Aid, Relief, and Economic Security Act, money allocated under the Anaheim Community and Economic Recovery Plan, state COVID-19 relief dollars, grants
- **Application periods:**
  - **Phase 1**
    - **First round:** June 1-5, 2020
    - **Second round:** Sept. 30-Oct. 16, 2020
  - **Phase 2**
    - **First round:** March 1-31, 2021
    - **Second round:** Aug. 2, 2021-current
- **Phase 1 applicants:** 1,446
- **Phase 2 applicants:**
  - **First round:** 2,285
  - **Second round:** ongoing
- **Rental assistance:**
  - **Phase 1 (city funds only):** up to \$2,100 for six months back rent
  - **Phase 2 (state and federal relief dollars):** initially covered 80 percent rent owed, then expanded to 100 percent owed since April 2020
- **Who qualifies:** tenants with household income 80 percent or 50 percent of Area Median Income for Orange County

## Take it Outdoors: Restaurant Relief Grant Program

- **What:** grants to Anaheim restaurants for building or expanding outdoor dining space
- **Why:** restaurants still have restrictions on indoor dining, being outdoors has been proven to have less risk for spread of virus
- **Amount:** restaurants can get up to \$2,000 to pay for shade structures or umbrellas, décor, barricades, renting tables and chairs, or other costs
- **When:** grants can be used for future costs or for reimbursement of spending since March 16, 2020
- **Available:** funds are limited, duration of program based on interest

## Restaurant Safe

- **What:** grants to Anaheim restaurants for building or expanding outdoor dining space
- **Why:** restaurants still have restrictions on indoor dining, being outdoors has been proven to have less risk for spread of virus
- **Amount:** restaurants can get up to \$2,000 to pay for shade structures or umbrellas, décor, barricades, renting tables and chairs, or other costs



## Utility Bill Help

- **What:** assistance with bills for water, electricity and internet service plus emergency small business assistance with utilities
- **Why:** many residents experienced financial hardship due to lost wages and, at the same time, many were working from home or had children doing online learning and needed adequate internet access
- **Program:** \$3 million

## Mask Giveaways

- **What:** drive-thru mask distribution events hosted by city of Anaheim
- **Why:** masks are a critical part of preventing the spread of coronavirus, especially as we look toward gradual reopening; targeting most impacted neighborhoods
- **When:**
  - Sept. 9, 2020 from 8 a.m. to noon
  - Sept. 16, 2020 from 4 to 8 p.m.
  - Sept. 26, 2020 from 8 a.m. to noon
- **Where:**
  - **Sept. 9:** Magnolia Baptist Church, 720 S. Magnolia Ave.
  - **Sept. 16:** Anaheim First Christian Church, 520 W. South St.
  - **Sept. 26:** Temple Beth Emet, 1770 W. Cerritos Ave.
- **Masks:** 90,500
- **Families served:** handed out 2,262 boxes of 40 masks, one per family
- **How:** federal COVID-19 relief funds allocated by City Council, volunteers
