Appendix A – Public Access NOV Permit Violations

### **Project Location and Setting**

The Project Site is an approximately 13.38-acres parcel developed with the Miraloma Groundwater Recharge Basin owned and operated by the Orange County Water District (OCWD). The Project Site is addressed at 3255 E. Miraloma Avenue, in California on Orange County Parcel Number APN 345-061-06. The Project Site is situated north of Miraloma Avenue, south of Orangethorpe Avenue, east of Kraemer Boulevard, and west of N. Miller Street in the City of Anaheim. The Project Site is accessed by driveways off Miraloma Avenue from the north. Neighboring properties include the Zuma Business Park to the east, Miller Groundwater Recharge Basin to the north, Miller Groundwater Recharge Basin to the west, and industrial and religious facility to the south.

The Project Site is zoned Open Space/Water (DA-6) of the Anaheim Canyon Specific Plan No. 2015-1 (ACSP). The Project site is bound to the east by Kraemer Boulevard and industrial warehousing and manufacturing uses and industrial uses beyond; to the north by E. Orangethorpe Avenue and Miller Basin with residential uses beyond; to the west by N. Kraemer Boulevard and Kraemer Basin with commercial uses beyond; and, Miraloma Avenue to the South and a religious and industrial uses, with commercial and industrial uses beyond.

### **Project Description**

The Proposed Project involves the operation of a seasonal aqua park that would operate annually from April to October; weather permitting. The proposed hours are as follows: Summer Hours (months May through September) Monday through Friday 10am to 7pm, Saturday and Sunday 9am to 7pm. Seasonal Hours (months of April and October) would be Monday through Friday 10am to 4pm and Saturday and Sunday 9am to 4pm. Temporary and removable improvements include the inflatable AquaPark equipment and buoy lines in the water, a pro-shop, a life jacket distribution unit, restrooms and sun shade structures; all of these items are modular/portable, as shown in Figure 1 – *Site Plan*.

**ACSP EIR No. 348 and MMRP No. 312**

As required by CEQA, the City prepared an Environmental Impact Report for the Anaheim Canyon Specific Plan (ACSP), which analyzed impacts associated with the establishment of the specific plan. On October 19, 2015 the City of Anaheim certified Final EIR No. 2013-00348 (EIR No. 348) and adopted Mitigation and Monitoring Program No. 312 (MMRP No. 312) for the Anaheim Canyon Specific Plan under resolution no. PC2015-083 and adopted general plan amendment no. 2014-00492 for the Anaheim Canyon Specific Plan under resolution no. PC2015-084.

EIR No. 348 addressed the air quality impacts associated with implementation of the ACSP. Refer to EIR No. 348, Section 5.2. EIR No. 348 concluded that after mitigation, significant and unavoidable impacts would still occur with respect to short-term construction emissions, long-term operational emissions, exposing sensitive receptors to substantial construction and operational pollutants, and violating air quality standards. The Anaheim City Council adopted a Statement of Overriding Considerations with regard to these potential impacts. After mitigation, EIR No. 348 concluded that implementation of the ACSP would have less than significant impacts with respect to creating objectionable odors that affect a substantial number of people.

EIR No. 348 and MMRP No. 312 detail the implementation of air quality mitigation measures **AQ-1** through **AQ-11** and transportation mitigation measures **T-1** through **T-3** to address air quality impacts. **AQ-11** establishes mitigation required for potential odor impacts.

**AQ-11:** For Projects located within 1,000 feet of an industrial facility that emits substantial odors, which includes but is not limited to:

- Wastewater treatment plants
- Composting, greenwaste, or recycling facilities
- Fiberglass manufacturing facilities
- Painting/coating operations
- Large-capacity coffee roasters
- Food-processing facilities

The property owner/developer shall submit an odor assessment to the Planning Director prior to approval of any future discretionary action that verifies that the South Coast Air Quality Management District (SCAQMD) has not received three or more verified odor complaints. If the Odor Assessment identifies that the facility has received three such complaints, the applicant will be required to identify and demonstrate that Best Available Control Technologies for Toxics (T-BACTs) are capable of reducing potential odors to an acceptable level, including appropriate enforcement mechanisms. T-BACTs may include, but are not limited to, scrubbers at the industrial facility, or installation of Minimum Efficiency Reporting Value (MERV) filters rated at



14 or better at all residential units.

The following odor assessment details verification for any potential odor emitting industrial facility located within 1,000 feet of the Project Site.

### **Odor Complaints and Public Nuisance Violations**

The Project Site is located within Southern California Air Basin (SoCAB). Members of the public within South Coast AQMD's four-county jurisdiction (Orange County and urban portions of Los Angeles, Riverside, and San Bernardino Counties) are encouraged to report air quality problems they observe, via the SCAQMD's phone line or via an online complaint reporting system, for investigation by SCAQMD inspectors.

Inspectors must confirm odors in the presence of sufficient numbers of public complainants, each at their own residence or workplace, then trace the odors to the operation of a unique source -- excluding other potential sources via upwind/downwind surveillance -- before enforcement action can be taken against the verified source of odors. Based on this evidence, a South Coast AQMD inspector may issue a Notice of Violation (NOV) against the source of nuisance odors for creating a public nuisance, in violation of South Coast AQMD Rule 402<sup>1</sup> and California Health and Safety Code Section 41700<sup>2</sup>.

As part of the SCAQMD's compliance program, inspectors visit facilities to determine if they are meeting clean air rules and regulations. If a facility is not in compliance, there are two types of tickets that the inspector may issue. One is called a Notice of Violation (NOV), the other is a Notice to Comply (NC). The following information explains each type of ticket. The SCAQMD maintains electronic records on the form of an on-line database of validated NOV's or NC's.

**Notice of Violation** - this type of ticket is issued if the facility has failed to comply with an SCAQMD rule or permit, or a state air pollution regulation. Often, these violations involve emissions of some kind. The facility is required to correct the problem, and there is usually a fine or penalty associated with this ticket.

**Notice to Comply** - this is a "fix it" ticket that is issued for minor administrative or paperwork violations that involve no, or minimal, emissions. Examples would include having incomplete records, or not posting a copy of the permit near the equipment. The facility is typically given two weeks to comply. If the recipient fixes the problem, SCAQMD does not take additional action. There is no fine associated with a Notice to Comply. However, if the problem is not fixed by the deadline, SCAQMD may issue a Notice of Violation.

### **Methods**

The SCAQMD maintains public records of NOV<sup>3</sup>, NOCs<sup>4</sup>, and NOV<sup>5</sup> which were issued, but permit conditions were violated<sup>5</sup>. SCAQMD also maintains a Facility Information Detail (FIND) map that contains information regarding facilities that are required to have a permit to operate equipment that releases pollutants into the air<sup>6</sup> (Appendix A). FIND makes SCAQMD data available in a more consolidated way to provide a "one-stop" location for finding facility information, including that of NOV<sup>3</sup> and/or NOCs. Since FIND incorporates public records or NOV<sup>3</sup> and NOCs, only FIND and public record permit violation (Appendix A) resources were utilized for compliance with EIR No. 348/MMRP No. 312 mitigation measure AQ-11.

**Odor Assessment**

Industrial facilities identified within 1,000 feet of the Project Site that may emit substantial odors are identified in **Table 1 – Potential Odor Emitting Facilities** below. A total of eight (8) facilities were identified.

### NOV Condition Violations

The SCAQMD database housing all NOV's issued to facilities who did not adhere to their permit conditions was further utilized to determine whether any of the facilities located in Table 1 above were ever in violation. A search was processed for all records within the City of Anaheim, beginning January 1, 1970 to June 30, 2020. The results<sup>13</sup> show no Rule 402 violations at any of the identified facilities in Table 1.

### Conclusion

No industrial potential odor emitting facilities located with 1,000 feet of the Project Site received more than three (3) odor violations. Therefore, the applicant is not required to identify and demonstrate that Best Available Control Technologies for Toxics (T-BACTs) are capable of reducing potential odors to an acceptable level, including appropriate enforcement mechanisms.
