

**ANAHEIM HOUSING AUTHORITY  
PROJECT BASED VOUCHER APPLICATION  
DIAMOND APARTMENTS HOMES**

The Anaheim Housing Authority (AHA) is accepting applications for Project Based Vouchers (PBVs) for an affordable housing project consisting of **one (1) bedroom** and **two (2) bedroom** apartments at Diamond Apartment Homes. This PBV can only be used to receive housing assistance at that project.

This opportunity is offered to eligible persons who meet the requirements listed below and who may qualify for a PBV apartment. Interested persons must meet both listed eligibility criteria and follow the instructions below. The application period for this project will remain open until further notice.

**Diamond Apartment Homes** is an affordable housing complex for homeless, disabled families who have special needs and is located at: 1310 W. Diamond St., Suite AA, Anaheim, CA 92801.

Total Household Income may not exceed 30% of Orange County Area Median Income as listed on the following website: <https://www.anaheim.net/675/Applicants>

**Eligibility Criteria:**

**1. Mental Health Services Act (MHSA) Eligibility (must check at least 1 box)**

- Adult or older adult with a severe and persistent mental illness (as defined in Welfare and Institutions Code 5600.3)
- Individual has a co-occurring mental health and substance abuse disorder

**2. Homelessness status (must check box)**

- An individual or family who lacks a fixed, regular, and adequate nighttime residence; and an individual who has a primary nighttime residence that is a supervised publicly or privately operated shelter designed to provide temporary living accommodations (including welfare hotels, congregate shelters, and transitional housing for the mentally ill); an institution that provides a temporary residence for individuals intended to be institutionalized; or a public or private place not designed for, or ordinarily used as, a regular sleeping accommodation for human beings. Homelessness has been continuous for one year or more, or there have been four episodes in a three year period.

**If you meet both eligible criteria 1 & 2 above** and are interested in applying for these PBV units, please **complete this form and fax** to Orange County Health Care Agency (OCHCA) at 714-564-4042 to obtain an approved MHSA Eligibility Certification.

Please do not contact Anaheim Housing Authority as you must be screened and referred by OC Health Care Agency. By completing this form, and signing below, I hereby authorize Anaheim Housing Authority to share the above information with outside agencies for eligibility purposes.
