**A/C Tune-Up Rebate Application**

The Anaheim Public Utilities A/C Tune-Up Rebate Program provides residential customers a rebate of up to a \$100 (\$150 for income-qualified customers) for getting an A/C tune-up. Customers are only eligible to participate in this Program once a year and applications must be submitted within 1 year of A/C tune-up service. Incentive amount not to exceed purchase price.
